#### 1. Introduction

The Housing (Regulation of Approved Housing Bodies) Act 2019 ("the Act") provides for the regulation of Approved Housing Bodies (AHBs) for the purposes of protecting housing assets provided or managed by such bodies. It seeks to support stronger governance, financial management and reporting, property and asset management and tenancy management by AHBs, with a focus on safeguarding investment made in the delivery of social housing by AHBs.

The purpose of the Request for Information form (RFI) is the initial gathering of information from AHBs that have been deemed registered with AHBRA under Section 34 of the Act.
