



## Publication of AHB names which failed to comply with a Section 36 Direction relating to the Annual Monitoring Programme 2025

To promote accountability and encourage regulatory compliance, the names of those AHBs that failed to comply with a Section 36 (“S36”) direction relating to the Annual Monitoring Programme 2025 are published below.

A S36 Direction is a statutory direction under Section 36 of the Housing (Regulation of Approved Housing Bodies) Act 2019 requiring an AHB to provide specified records or information to AHBRA. The 51 AHBs listed below were issued with S36 directions under the Annual Monitoring Programme, requiring them to submit a completed Annual Monitoring Form (AMF) and their most recent financial statements by a specified deadline. These AHBs either failed to submit the required information, provided incomplete submissions that did not meet AHBRA’s requirements or submitted after the specified deadline.

AHBs marked \* in the list below submitted the required information after the deadline.
